I was contacted by Emily Ruark, Deputy Clerk for the Morgan County Magistrate Court in reference to Mr. Derrick Williamson causing a verbal disturbance in Judge Connie Holt's private office.

Mr. Williamson's purpose for being in the Judge's Office was to discuss a previous Good Behavior hearing held in April, between Mr. Williamson and Claire, James, and Janice Hardy.

Upon arrival, I stood at the doorway to Judge Holt's office and observed Mr. Williamson seated at the desk before Judge Holt, arguing over the results of the hearing. I made eye contact with Judge Holt and she instructed Mr. Williamson if he did not calm himself she would hold him in contempt. Mr. Williamson stood up while continuing to argue his position.

I entered the office upon Mr. Williamson standing up and positioned myself between Judge Holt and Mr. Williamson. I stood by to keep the peace as they continued their conversation. Upon becoming aware of my presence, Mr. Williamson lowered the register of his voice.

Mr. Williamson stated Judge Holt and the county had violated his civil rights. Mr. Williamson stated he would be contacting a civil rights lawyer and the media to "bring awareness to the corruption in this county". Judge Holt told Mr. Williamson she had not violated his rights and he was welcome to a copy of the audio transcript and stated he should consult an attorney.

Mr. Williamson agreed to leave when Judge Holt indicated she was done with the conversation. Judge Holt stated she did not need any further action taken with Mr. Williamson, other than allowing him to file for a copy of the audio transcript of the previous Good Behavior hearing. I advised Judge Holt I would observe to make sure Mr. Williamson left the courthouse peacefully.

Mr. Williamson left the building with no further action taken.
