On March 15, 2022, I, Deputy Miguel Ocon, was dispatched to 1280 Broughton Trail in reference to suspected stolen animals, and fencing. I made contact with Mr. Derrick Williamson. Mr. Williamson stated he is the CEO, CFO, and much more of a company. This company of his is at 1280 Broughton Trail. Mr. Williamson stated he lives there and that he lets people rent his house and share the house. Mr. Williamson stated he collects exotic animals as a shelter of some sort and that Mrs. Janet Hardee was kind enough to donate a lot of money to the company. Mr. Williamson stated he was so appreciative that he let Mrs. Janet move into his house and pay the bills.

I made contact with Mrs. Janet who stated she did donate a lot of money to the company. Mrs. Janet stated she lives there with her two daughters, mother-in-law, one grandchild, and Mr. Williamson. Mrs. Janet stated she built the home and stated Mr. Williamson has another home somewhere else. Mrs. Janet stated the last time Mr. Williamson stayed at the house was two months ago. Mrs. Janet stated Mr. Williamson is trying to get them evicted from the house. Mrs. Janet stated she met Mr. Williamson at church and they became real close. Mrs. Janet stated the missing animals and the fence was taken by a David. David is a subject who works with Mrs. Janet and Mrs. Williamson. Mrs. Janet stated she bought some of the animals. I advised to both Mrs. Janet and Mr. Williamson that this is a civil issue. Both stated they have lawyers attempting to get this misunderstanding resolved.

On March 16, 2022, I was dispatched to investigate a physical domestic dispute. Upon my arrival, Mr. Williamson was outside holding his right shoulder and stated he had been assaulted by Mr. James Hardee. Mr. Williamson requested E.M.S. to clear him and National E.M.S. 1201 was dispatched to my location. Mr. Williamson presented a video and in the video there is a lot of yelling from multiple people. Mr. Williamson stated he was attempting to retrieve his personal documents that were located in a drawer in the living room. In the video I saw Mrs. Janet, Miss Claire Hardee, and Mr. James. Mr. Williamson was seen standing at the cabinet with Mrs. Janet and Miss Claire. Mr. James came into the video and was seen slamming the cabinet drawer. Mr. Williamson walked backwards, started screaming, and yelling he was going to call the police.

Mrs. Janet and Miss Claire both stated Mr. Williamson touched them while Mr. Williamson was trying to open the drawer. Mr. Williamson stated he did not touch anyone. Mr. James stated he did not touch Mr. Williamson deliberately but just slammed the drawer.

Mr. Williamson was holding a portfolio in his left arm and placed it in his right arm, the same arm that he stated was injured. Mr. Williamson was taken to the Morgan Medical Hospital for further examination. No marks were observed on his arm.

Since February 23, 2022, the Morgan County Sheriff's Office had been dispatched six times in reference to this same incident involving all parties present. Calls vary from subject refusing to leave to evicting someone from the property. I was unable to determine the primary aggressor at this time and I am requesting a good behavior hearing to resolve this dispute between all parties.
