This order was served by Rockdale County Sheriff's Office, Deputy Anna Monti, Badge number 2522 on Monday, February 27, 2023 at approximately 12:47 P.M.

Today, March 3, 2023, Magistrate Clerk Julie Ruark, brought a written statement that on Tuesday, February 28, 2023 at approximately 8:50 P.M. and again on Thursday, March 2, 2023 at approximately 6:39 P.M. Mr. Williamson shared a "TikTok" video that a Jay Megan made on his Facebook page in reference to Judge Connie Holt. That video was removed on or around February 28, 2023 but then again reposted on March 2, 2023. Mrs. Ruark does have screen shots of this evidence as well as a video screen recordings.
